**STIPULATION AND
CONSENT ORDER**

On this 25th day of August, 2005, the Iowa Board of Dental Examiners and Bruce S. Kuhn, D.D.S., each hereby agree with the other and stipulate as follows:

The licensee disciplinary hearing scheduled to commence before the Iowa Board of Dental Examiners on the 25th day of August, 2005, on the allegations specified in the Statement of Charges which is attached to the Notice of Hearing dated May 11, 2005, shall be resolved without proceeding to hearing, as the parties have agreed to the following Stipulation and Consent Order:

1. That Respondent was issued a license to practice dentistry on the 14th day of July, 1988, as evidenced by License Number 7350 which is recorded in Book D, Page 50, of the permanent records in the office of the Iowa Board of Dental Examiners.
2. That Iowa Dental License Number 7350 is current and in full force until June 30, 2006.
3. That the Iowa Board of Dental Examiners has jurisdiction over the parties and subject matter herein.
4. A Notice of Hearing and Statement of Charges was filed against Respondent on May 11, 2005.

THEREFORE, IT IS HEREBY ORDERED that Respondent is hereby issued a **CITATION AND WARNING** for having disciplinary action taken against him by another state, and for failing to report a license revocation, suspension, or other disciplinary action taken by a licensing authority of another state within thirty (30) days of the final action, as required by Iowa Administrative Code 650-30.4(32).

SECTION I.

IT IS FURTHER ORDERED:

1. Respondent shall comply with all requirements of the Agreed Settlement that he entered into with the Nebraska Department of Health and Human Services Regulation and Licensure, which was approved on January 19th, 2005.
2. Respondent shall immediately notify the Board concerning any issues of non-compliance with the requirements of the Agreed Settlement.

SECTION II.

1. The Respondent acknowledges that he has read in its entirety the foregoing Stipulation and Consent Order and that he understands its content and that he enters into this Order freely and voluntarily.
2. Respondent agrees this Stipulation and Consent Order constitutes the resolution of a pending contested case. By entering into this Stipulation and Consent Order, the Respondent voluntarily waives any right to a contested case hearing on allegations contained in the Statement of Charges, and waives any objections to this Stipulation and Consent Order.
3. Respondent acknowledges that he has the right to be represented by counsel in this matter.

4. Respondent understands that this Order is a public record and is therefore subject to inspection and copying by members of the public.
5. Respondent understands that the Board will report this Order to the National Practitioner Data Bank and Healthcare Integrity and Protection Data Bank.
6. Respondent acknowledges that no member of the Board, nor any employee, nor attorney for the Board, has coerced, intimidated, or pressured him, in any way whatsoever, to execute this Order.
7. Respondent acknowledges that this proposed settlement is subject to approval of a majority of the full Board. If the Board fails to approve this proposed settlement, it shall be of no force or effect to either party.
8. Respondent shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dentistry in Iowa. Any violation of the terms of this Order is grounds for further disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code Section 272C.3(2)(a) (2005).

This Stipulation and Consent Order is voluntarily submitted on this 29 day of July, 2005.


